At the outset, Member Secretary welcomed, Hon'ble Chairperson, Members of the Commission and new Joint Secretary. Thereafter, she briefed all members of the Screening Committee about agenda items. Thereafter discussion was held on all Agenda points.

Agenda -1. To consider the proposals received for financial assistance from NGOs, Institutions, and Universities for undertaking Research Studies, and organizing Workshops, Seminars, Public Hearings, Legal Awareness Programme (LAP) and Parivarik Mahila Lok Adalat (PMLA).

After deliberation, the Commission approved the proposals which were recommended by Chairperson and Members which fall in the eligible category as vital documents have been received.

The Commission further decided that the circular to invite proposals on the above shortlisted topics from Universities, State Women Commissions, other reputed Institutions and Non-Governmental Organizations is to be placed on the website clearly indicating the last date of the receipt of proposals 30 days after its uploading and no direct proposals would be entertained by the Commission in future.

Agenda -3. Financial Assistance provided to NGOs to impart Legal Awareness to girls and women in order to empower them of their rights.

To review the performance of the organizations holding Legal Awareness Programme (LAP), Dr. Charu WaliKhanna, Member, NCW has devised a format which was discussed in the meeting and the Commission decided to adopt recommended reporting format.

Agenda - 4. The revision of the Guidelines for grant of financial assistance to NGOs and others for undertaking Research Studies and organizing Workshops/Seminars, Public Hearings, Legal Awareness Programme (LAP) and Parivarik Mahila Lok Adalat (PMLA).

Since, Guidelines for grant of financial assistance to NGOs and others for undertaking Research Studies and organizing Workshops/Seminars, Public Hearings, Legal Awareness Programme (LAP) and Parivarik Mahila Lok Adalat (PMLA) are sketchy at present and do not fulfil the purpose of identifying good NGOs, the Commission decided to further review and revise the Guidelines.

Additional Agenda

The issue of Petition filed in the Supreme Court on Child Marriage Act was discussed. It was decided to conduct Consultation in the Commission for arriving at a consensus in the matter.

It was further decided that Members may conduct programmes and recommend proposals not included in the Agenda Item 1, for conducting consultation on selected topics. In this regard, Smt. Nirmala Samant Prabhavalkar, Member, NCW suggested National level Consultation in Mumbai and Chennai on "Portrayal of Women in Media - and Role of CBFC and Minister (I&B)" and this proposal was approved by the Commission.

The Commission may also conduct programmes in collaboration with College, Universities, State Women Commissions etc.

The meeting ended with a vote of thanks to the chair.
