The minimum age limit is 45 years for civil servants with legal background & experience and lawyer. Retired Officers (Deputy Secretary Rank) of Ministry of Law and Justice, Government of India may also apply along with bio-data, who if found fit/competent, could be appointed on contract basis for one year initially, extendable to 3 years. The Army/Air force/Navy Officer who are/were part of legal branch can also apply on deputation basis/contract basis. The maximum age at the time of applying for retired official would be 62 years. Subject:- Filling of the post of Law Officer in the National Commission for women by deputation basis on 'foreign Service Terms'.

Sir,

The National Commission for Women (NCW) intends to fill up one post of Law Officer in the scale of pay Rs.15600-39100+6600(GP) indicated hereunder by deputation on 'foreign service terms'/contract basis. The eligibility conditions are as under:-

Name of the post & scale of pay	No. of posts	Eligibility conditions
Law Officer Rs.15600- 39100+6600(GP)	1 (One)	i) Holding analogous post on regular basis or ii) Government Officers with 8 years service in the scale of Rs.9300-34800+4800(GP) possessing a Degree in Law from a recognized University with a minimum of 5 years of experience as Law Officer and experience in dealing with Human Right issues iii) Preference will be given to those who have sufficient expertise in computer iv) Period of tenure of deputation including the period of deputation in ex-cadre posts held immediately preceding the appointment in the same or any other organization/department or the Central Government should not ordinarily exceed three years. v) For retired officers – the contract will be for one year to start with and maximum 5 years or 65 years of age whichever is earlier. The emoluments will be last pay drawn minus pension.

- i) The period of deputation for the above post will be initially for a period of one year and is likely to be extended from time to time for a maximum period of three years, at the discretion of the Commission.
- ii) The persons deputed to the post will be entitled to the retention of General Pool Accommodation.
- iii) During the period of deputation, the deputed persons will be allowed to draw 5% deputation (duty) allowance or scale of pay of the post, if they opt for it.
- iv) Leave and Pension Contribution at the prescribed rates, will be paid by the foreign employer.

It may be ensured that the applications of the eligible candidates in the prescribed format may please be forwarded through proper channel along with attested copies of ACRs for the last 5 years and vigilance clearance to avoid delay in the selection of the candidates latest by 15th May 2010 to the Under Secretary, National Commission for Women, 4, Deen Dayal Upadhyaya Marg, New Delhi - 110 002. No application will be considered without Vigilance Clearance.
