NATIONAL COMMISSION F O R WOMEN

10th Anniversary of NRI Cell

National Commission for Woman was nominated as the Coordinating agency at the National level for dealing with issues pertaining NRI marriages by the Ministry of Overseas Indian Affairs in the year 2008. The NRI Cell was formally established on 24th September 2009 to deal with complaints received from India and abroad on marital disputes between an Indian woman from India and an Indian man residing in another country (thus NRI - non-resident Indian), either as Indian citizen (when he would legally be an 'NRI') or as citizen of that other country (when he would legally be a PIO - person of Indian origin).

On the successful completion of 10 years of the NRI Cell, a seminar was organized by the Commission in collaboration with Punjab School of Law and National Women's Centre, Punjabi University, Patiala on 'NRI Marriages and Related Issues' on 27th September 2019 to initiate deliberations on the effectiveness of legal remedies available for the Indian women affected on account of various issues involved in NRI marriages. The Commission intends to come up with a collective and wider view on the NRI marriage related issues and rethink the existing approaches and interventions.

Hon'ble Chairperson Smt. Rekha Sharma chaired the seminar. Other attendees were Sh. A. Asholi Chalai, Joint Secretary NCW, Dr. BS Ghuman Vice Chancellor of Punjabi University, Mr. Justice (Retd.) Rakesh Kumar Punjab State Commission for NRI Chandigarh and other various stakeholders actively engaged on this issue.

Interactive meeting with State Women's Commission

The National Commission for Women organised one day interactive meeting with the State Women Commissions on 30th September 2019. The meeting was chaired by Hon'ble Chairperson Smt. Rekha Sharma and held at Narmada district in Gujarat. The Commission conducts interactive meetings with State Commissions for Women at regular intervals. These meetings serve

as a bridge between the Commissions so that they are able to work together efficiently as a cohesive unit for the betterment of women across the country. Members and Chairpersons of various commissions exchange their views on burning issues related to women in these meetings.

News on Women

Indian Army aims to induct 100 women soldiers every year for the next 17 years to reach 1700 women soldiers in the Military Police. As per reports, the selection of the first 100 women soldiers is underway and their training (for 61 weeks) will start in December this year.



The first all women post office started operations in Patna this month. Christened 'Mahila Dak Ghar', the post office is situated on the premises of the Bihar Public Service Commission. This Mahila Dak Ghar will offer both traditional and modern services. Post offices in India are used not just to post or speed post items and letters or documents but it's a centre for paying bills, registering fixed deposits under the postal schemes and for money transfers.



India's first International Women's Trade Centre (iWTC), under the Gender Park in line with the United Nations Sustainable Development Goals (SDGs). The centre, to be set up in Kozhikode, also aims to secure gender pay parity.

National Commission for Women has launched a one day countrywide legal awareness Programme for students of Central and State Universities and Colleges affiliated to them and UGC deemed Universities on 9th September 2019. Ninety-two institutions have been onboarded so far under the initiative.
