## Sexual Harassment of women at work place –Review of the Law



NCW, in terms of Section 10 (d) of the NCW Act, 1990 decided to hold series of consultations with stakeholders, so as to review the Sexual Harassment of Women at Work Place (Prevention, prohibition and Redressal) Act 2013.

The present Act is based on a draft prepared by NCW in 2010 drawing on Supreme Court's Vishaka's Judgment 1997 and inter alia provides for the constitution of an Internal Complaints Committee (ICC) at all work places, where the number of employees is 10 or more. In cases where the number of employees is fewer, there is a provision for Local Complaints Committee (LCC) under the District Collector. The law also provides for the complainants to be penalized, under Section 14 of the Act, where ICC or LCC arrives at a conclusion that the allegation is malicious. Similarly, there are issues of implementation. As such, broader consultations were essential to understand the nature of emerging issues so that the appropriate action could be initiated regardingstrengthening of implementation mechanism or amendment to the law.

One-day consultation on law review of "Sexual Harassment of Women at Workplace" (Prevention, Prohibition and Redressal) Act, 2013 was, therefore, held in the Commission's Conference Hall on 17<sup>th</sup> November 2018 wherein experts including Justice Sujata V Manohar (Retd.), Justice G. # Information and Broadcasting Ministry urged to constitute ICC in media houses

In the month of October 2018, NCW urged I&B Ministry to direct print, publication and production houses to form the Internal Complaints Committee, to probe complaints of sexual harassment at work place. NCW urged Secretary I&B to issue directions to ensure that the organizations such as printing/publishing/production Houses involved in TV/ film production need to put in place an effective mechanism for addressing complaints related to sexual harassment through the mechanism of constituting Internal Complaints Committee under the provisions of the Sexual Harassment of Women at Work Place (Prevention, prohibition and Redressal) Act 2013.

Dr L R Agrwal, Ms Sunita Dhar, Advisor Jagori, Ms Anuradha kapoor Activist Swayam, Adv Anutosh Singh, Adv Ms Madhu Mehra Adv. Ms Flavia Agnes, Ms Annie Raja of NFIW, Ms Vani Subramanium Activist Saheli, Adv. Madhu Mehra, attended the consultation.

Following Recommendations were made by the participants after due deliberations:

- NCW should organize regional consultation across the country before making recommendations to the Government.
- ii) There is a need for greater clarity on the point of prevention.
- iii) Proper mechanism is needed for monitoring the implementation of the Act with a specified authority.
- iv) Inquiry process in such cases should adhere to the provisions of the Act.
- v) Conciliation clause in the Act needs to be reviewed.
- vi) Options need to be available with a well defined Appellate authority in case of the victim being dissatisfied with the enquiry.
- vii) Regular training of the members of Internal Committee/Local Committee and evolving a standard training module.
- viii) Details of IC/LC with their contact number to be made available on an e-portal.

#### NRI marriages- NCW writes to Hon'ble Minister of External Affairs

NCW wrote to Smt. Sushma Swaraj External Affairs Minister regarding plight of Indian women in NRI marriages on 3.10.2018. In it's letter to the Minister, the Commission wrote that despite the marriages having been solemnised in accordance with Indian laws, foreign courts often decide the cases and dissolve marriages and pass ex-parte divorce decree in many cases. The decisions are taken on the ground of 'currently not available' by misusing the provision in the foreign laws. The Commission highlighted its view that dissolution of marriages in such cases should take place in accordance with the laws and in the country where the marriage was solemnised, as the Indian women in NRI marriages are often left without any financial support. The Commission, therefore, suggested to the Ministry of External Affairs to explore the feasibility of bilateral treaties with countries having sizeable presence of India diaspora.

## Seminar in Chandigarh on Economic Rehabilitation of Women aggrieved in NRI Marriages

The Commission organized a consultation meeting on 31.10.2018 at Punjab University Chandigarh, with concerned stake holders and deliberated on the issue of economic rehabilitation of women aggrieved of NRI marriages. The important participants in the meet were academicians from Department of Social Work and Punjab University, representatives from socio religious organizations like Shiromani Gurudwara Prabandak Committee, DAV management Committee and representatives from civil society organizations of 13 districts of Punjab. The meet discussed the possible role of different stake holders and prepared a tentative plan of implementation and monitoring of the programme of economic rehabilitation of women aggrieved in NRI marriages.

The meeting was chaired by Ms. Rekha Sharma, Chairperson, NCW and attended by Member and Officials of NCW namely Smt. Soso Shaiza, Member, NCW, Shri. A. Asholi Chalai, Joint Secretary, NCW and Ms. M. Lilabati, Sr. Coordinator, NCW Delhi, Ms. Pauline, Media Adviser and Geeta Rathi, JTE. The participants from the SCWs included Dr. M. Binota, Chairperson, Manipur; Ms. Yheilin Phanbuh, Chairperson, Meghalaya, Ms. Barnali Goswami,



Chairperson, Tripura; Ms. Chikimiki Talukdar, Chairperson, Assam; besides Ms. Niyati Dey, Member, Assam; Ms. S. Neelima Devi and Ranjita Golmei, Members from Manipur, Ms. Zodinthangi and Ms. Lalrinnawmi Members from Mizoram.

Dr. M. Binota, Chiarperson, Manipur SWC, welcomed the august gathering as the host of the meeting and emphasized the need for legal awareness among Women and prevention of crime against them. Smt. Rekha Sharma, Chairperson, NCW, appreciated the hospitality skills of the women in the North Eastern States and its remarkable potential for tourism. She referred to the earlier training given in July 2018, by NCW, in collaboration with Airbnb and expressed the desire to organize more such training, depending upon the feedback about their utility.

The SCWs raised the need for having full time Member Secretaries as in most of the States, they were having dual charge. After detailed deliberations the actionable points were identified as:

- State Commissions to organize LAPs and submit the details of the expenditure for release of the second installment, so as to settle the accounts before further programmes are approved by NCW.
- ii) Capacity Building programme for Assam Police shall be taken up by NCW.
- iii) Members, NCW will visit the State to ensure grant and infrastructure for SCWs.

Smt. Kamlesh Gautam: She assumed the office of the Member. National Commission for Women on November 19th, 2018 for the tenure of 3 years. She has a Post Graduate degree from Kanpur University and has been an active member of various youth and women centric organizations at the district level in Uttar Pradesh since 1995. She has also held the post of President, Shri Sai Seva Shikshan Sanstha, an NGO that works towards empowering children

through education.



Smt. Soso Shaiza: She assumed the office of the Member, National Commission for Women on November 19, 2018 for the tenure of 3 years. She is a prominent educationist from the State of Manipur, where she has worked extensively on bringing quality education to all the people, especially the tribal women of Manipur and the youth in the district of Ukhrul, since the early 1980s. Smt. Shaiza is the Founder and Advisor of Hunphun Shanao Long's (Ukhrul Women

Union) Education Project. She is also the founder of the first private-run CBSE-affiliated Little Angels' English School in Ukhrul, which has seen more than 7000 students successfully complete their high school since its inceptions over 30 years ago. She is credited for her role in the inclusion of the Tangkhul language in the CBSE curriculum; making it the first tribal language recognized as a 'Modern Indian Language' by the CBSE. In 2011, she was conferred the "Best Educationist Award" and a "Certificate of

Education Excellence" for her outstanding achievements by the International Institute of Education Management, New Delhi. She was also conferred the 'Asia-Pacific Gold Star Award' by the Global Achievers' Foundation in Dubai, UAE in 2011. Through her various projects, Smt. Shaiza has been actively engaging with young girls, women, widows and orphans in Manipur. She has organized numerous seminars, workshops, conferences and youth camps on subjects related to personality development, adult literacy, drug abuse & its effects on the family, women empowerment and various other women related issues in the state.



Smt. Chandramukhi Devi: She assumed the charge of Member, National Commission for Women on 26 November 2018 for the tenure of 3 years. She is a graduate of Hindi Sahitya. She has been involved with various women-related organizations in different capacities since 1988. In 1995, she was elected to the then undivided Bihar State Legislative Assembly, making her the first woman MLA from Khagria constituency in Bihar. The same year, she was

nominated for the Women and Child Development Committee. She also served as a Member of the Social Welfare Board Committee, NIPCCD. In 2010, she was made a Member of The Council for Advancement of People's Action and Rural Technology (CAPART). She has also previously held the post of Vice-President, Twenty Point Programme, Government of Bihar. Smt. Chandramukhi Devi was a Member of the Bihar State Commission for Women from 2011 to 2014.

#### Smt. Meenakshi Gupta joined as Member Secreatary

#### SUO- MOTO Cell

Some of the important cases on which the Commission took suo-moto cognizance are mentioned below

#### "A.P. woman alleges forced surrogacy"

The Commission took cognizance of the media report published in The Hindu, Delhi dated 9.10.2018 wherein it was alleged that a woman was lured for surrogacy and subsequently had been detained and given injection when she refused.

"Man throws acid on Assam student for refusing marriage"

The media report appeared in Hindustan Times, Delhi dated 09.10.18. The Commission sought detailed action taken report from Assam State Commission for Women.

"Death of a child and mother during delivery at General Hospital"

The news was published in various national dailies dated 28 11 2018 wherein, it was reported that a pregnant woman and her baby died after she was operated by an inebriated doctor. The Commission sought detailed action taken report from the State Govt. of Gujarat. The Commission was informed that an inquiry was conducted and gross negligence on the part of Doctor and staff was proved, leading to arrest of the accused doctor.

#### "On her way to police station, women set ablaze by harassers'

The news was published in various national dailies dated 03.12.2018 wherein, it was stated that a woman was burnt alive while she was going to the police station in Sitapur. The Commission sought detailed action taken report from the Police Department, Uttar Pradesh. The Commission was informed that the accused was arrested pursuant to a complaint registered against him. Also, a departmental inquiry was conducted against the callous Police Officials, where they were found to be negligent and as a result they were suspended.

#### Crime against women in Teerthankar Mahaveer University, Moradabad

The Commission took cognizance of a report informing that there were crimes against women in Teerthankar Mahaveer University, Moradabad, alleging that a recent incident of suicide by a student was due to this reason. The Commission constituted a two Member fact finding team comprising of Smt. Chandramukhi Devi, Member and Shri. Praveen Singh, Counselor which visited Moradabad on 14.12.2018. The team did not find any prima facie evidence about the alleged incident of rape in the University. However, the University authorities were advised to take due care about security of students and to be more sensitive towards gender issues and directed the Police authorities to expeditiously conclude the probe in the suicide case.

#### "Second Woman claims HIV infection from the Blood Transfusion in Tamil Nadu"

The news appeared in various News Channels on 29.12.2018 wherein, it was reported that a 27 year old woman had contacted virus during blood transfusion procedure in Kilpauk Medical College Hospital. The Commission sought detailed action taken report from Health & Family Department, Govt. of Tamil Nadu. The Commission was informed that an inquiry was conducted and it was found that the complaint was false as the woman had not contracted the HIV infection secondary to the Blood transfusion performed at the hospital.

Visited Tabitha Children Home at Mantripukri, Imphal, Manipur on 06.12.2018 and appreciated the services for welfare of the orphans, especially to those living with HIV/ AIDS.

- Attended felicitation programme on 06.12.2018, hosted by Hon'ble Shri N. Biren Singh, Chief Minister of Manipur and his cabinet ministers in Imphal.
- > Attended the 'Observation of 16 Days Activism of Gender Based Violence' as chief guest in Ukhrul, Manipur, on 08.12.2018, organised by Action of Women in Development (AWID) in collaboration with Department of Social Welfare, Ukhrul.
- Held meeting on 08.12.2018 with the Ukhrul District Level Officers in Manipur and discussed women-related issues and various government developmental schemes
- > Attended 'Justice for Millions' function on 10.12.2018 as chief panellist on'Appeal for Action Against Human Trafficking' in New Delhi, organised by Prayas, an NGO based in Delhi.
- > Attended the Broadcasting Content Complaints Council (BCCC) meeting, chaired by Justice Vikramajit Sen (Retd.), on 13.12.2018, as a representative of NCW along with Shri Priyank Kanoongo, Chairperson, NCPCR in New Delhi.
- Visited Swadhar Greh, a shelter home, in one of Kabui village at Keikhu on 21.12.2018 in Imphal, Manipur along with the Chairperson of the Manipur State Commission for Women. Run by an NGO, named as Environment & Economic Management Association (EEMA), this shelter home needs attention from the concerned authorities.
- Met Union Minister Shri Kiren Rijiju at his office on 30.12.2018 and discussed on issues of northeast women living in metropolitan cities among others.

#### Complaint and Investigation Cell

Complaint from Udaipur, Rajasthan- Investigation by NCW: The NCW received a complaint from a young woman resident of Udaipur, Rajasthan against her parents alleging that her family was forcing her to marry and has kept her under confinement. A two member Fact Finding Team along with the concerned police officer visited Udaipur on 8th October, 2018 to inquire into the matter and met the complainant and her family. The team was assured that the family of the complainant would not compel her to marry without her wishes. The team directed the local police officials to monitor the case

#### Legal Awareness Programmes



A two-day Legal Awareness Programme was organized by the Commission from 11.12.2018 to 12.12.2018 in Belonia District of South Tripura to enable women and girls about their legal rights, and the procedure and method of access to the legal system.



Jan Sunwai Considering the increase in the number of complaints and to ensure their speedy and effective disposal, the Commission conducts Mahila Jan Sunwai in collaboration with District legal Service Authority and concerned police Authorities at District level in different States. They are chaired by Chairperson or/and Members of the Commission. During the month of December 2018 Jan Sunwai was held in the two Districts of U.P. namely Agra and Ghaziabad on 28.12.2018. Another Jan Sunwai was held on 29.12.2018 at North Delhi. Cases were heard and additione of provide leved the Commission also increase on U.S.A. in addition to number of cases closed, the Commission also issued suitable directions to DLSA/



#### Psychiatric Home and Custodial Home Reform Cell:

The Commission evolved a comprehensive proforma in November 2018 to gather all the relevant information related to status of female patients in the Psychiatric Homes and sent it to 34 Government Psychiatric Homes in Govt. sector in December 2018. The information received in the proforma is being scrutinized in the Commission

Gender Sensitization: As part of an ongoing endeavor to bring a higher level of sensitivity among police personnel, a Gender Sensitization Programme was conducted by the Commission for 984 officers of Delhi Police on 29.12.2018 at Police Training Centre, Jhadoda Kala, New Delhi in two groups. The Commission's expert gender trainers namely, Ms. Chetna Soni, Research Officer, Mr. Sarvesh Pandey, Counsellor, MR. Piyush Chabbra, JTE(Legal) and Ms. Avni Bahari JTE(Legal), conducted interactive sessions on the topics; i) Gender as a social construct and accessibility of the police and ii) Crime against women and the Role of police. Shri. Nitish Chandan of Cyber Peace Foundation conducted the sessions on Cyber crime. The goal was to sensitize officers on gender issues and empower the police force with the ability to perform their duties more effectively and without prejudice and discrimination.
