INTERNATIONAL DAY FOR THE ELIMINATION OF VIOLENCE AGAINST WOMEN

Violence against women and girls remains one of the most grievous human rights violations in the world. However, under-reporting these crimes is one of the biggest challenges for organizations worldwide to eliminate gender-based violence. During 2020, the International Day for Eliminating Violence against Women was based on the theme of **"Orange the World: Fund, Respond, Prevent, and Collect!"** Followed by 16 days of activism which started on November 25 and ended on December 10, 2020, the International Human Rights Day.

The National Commission for Women marked the International Day for Elimination of Violence against Women with a three-day deliberation titled "India Against Abuse on Women," where the Commission brought together eminent scholars from Government, law enforcement agencies, NGOs, professionals, and activists to have a comprehensive and meaningful conversation on attitudes, perceptions, and ways to curb abuse against women and girls.

<u>LAW REVIEW CONSULTATION</u> <u>CYBERCRIME AGAINST WOMEN – DO INDECENT REPRESENTATION</u> <u>OF WOMEN'S ACT, IT ACT, AND OTHER PREVAILING LAWS SUFFICE</u>

Cyber Crimes against Women have a detrimental effect on women's well-being, psychological and mental health, and dignity. The constant fear of safety and loss of reputation adversely affects every aspect of their life. Furthermore, as technology advances, the forms, type, and way cybercrimes are bound to change. As a result, current laws must be updated to stay relevant and helpful to cybercrime victims to keep women safe from cybercrime.

The National Commission for Women held a series of Law Review Consultations from 21st August to 2nd December 2020 on "Cyber Crime against Women – Do Indecent Representation of Women's Act; It Act and Other Prevailing Laws Suffice" to strengthen women's rights the available redressal mechanisms for them to fight cybercrime.

The consultation was held to examine and discuss the establishment of regulatory instruments, statutes, suggestions, guidelines, and other measures to protect women's privacy and related interests in cyberspace. These instruments form a field of law and policy that has attained considerable maturity, spread, and normative importance over the decades. Through this consultation, the Commission sought views, suggestions, and opinions of stakeholders from Northern, Southern, Eastern, Western, and Northeastern regions of India to formulate consolidated recommendations for possible amendments in the existing law.

INDIA AGAINST ABUSE ON WOMEN

A gender unequal society is where women are denied their rights and are often subjected to physical and sexual violence by their partner. The more gender unequal a society is, the more likely they face discrimination and abuse in their daily lives. Discriminatory societal norms lead to gender-based violence where the primary victims are primarily women. In this backdrop, the Commission organized an 18-hour virtual discussion, spread over three days, titled "India Against Abuse on Women and Girls", from 25th to 27th November,2020, where experts discussed various issues and challenges faced by women and girls. The Commission brought together eminent scholars from Government, law enforcement agencies, NGOs, professionals, and activists to have a comprehensive and meaningful conversation on attitudes, perceptions, and ways to curb abuse against women and girls.



HOW ONLINE ABUSE OF WOMEN HAS SPIRALEDOUT OF CONTROL

Cybercrime against women is advancing much quicker, which creates a multitude of problems because as cyberspace expands, it creates more open areas for cybercriminals to penetrate. The problem lies in the modus operandi and the persistence of cybercriminals. The transcendental jurisdiction of the Internet causes a major threat to society in the form of cybercrime. The Commission held a session on 'How Online Abuse of Women Has Spiraled out of Control' to check the efficacy of the mechanism, including the responsibility of social media platforms in controlling the cyber abuse against women.

CONVERSATION AROUND SEXUAL HARASSMENT

& ENDING STIGMA AROUND MENTAL HEALTH

A large segment of women has experienced physical or sexual violence from an intimate partner in their lifetime. If a person has a mental illness, the suffering becomes twofold. To address the issues of victims of sexual harassment and women stigmatized because of mental health issues, the Commission conducted two sessions, namely, 'The Conversation around Sexual Harassment' and 'Let's end the stigma around mental health.' Through discussion, its the Commission attempted to address the preconceptions and biases that women encounter at various stages of their lives, robbing them of the chances to live a dignified existence.





DOMESTIC VIOLENCE AGAINST WOMEN - IT'S A MEN'S ISSUE

Every government and non-government statistics indicate that domestic violence being one of the prominent violence faced by women. The public concern about violence outside the home, which results in advice to women about how they should dress and stay off public spaces, obfuscates the enormity of intimate terrorism. Accounts of survivors reveal how other women in the family watch helplessly. Because of its position inside the house and the perpetrator, a close family, this abuse goes unreported primarily. The Commission, therefore, held a session on 'Domestic Violence against women -- it's a men's issue.'



National Commission for Women successfully held virtual Mahila Jan Sunwai on 09.11.2020 at NCW Southeast Delhi. The Commission took up a total of 29 cases for One Day Jan Sunwai. The Mahila Jan Sunwai has taken place with the coordination of the Police Officials in this regard. The parties were heard during the Mahila Jan Sunwai, and the matters were also taken up with the police officials for speedy remedial action.

Total 29 cases were taken up by the Commission in which 3 cases were closed based on compromise between the parties, 4 cases are closed based on being sub judice, 3 cases are forwarded for counseling, 4 cases are closed as the complainants did not want further action and 15 other cases police had sought time to file the action Taken reports in the matter. Thereafter, the police have yet to send action taken reports in more matters.

Smt. Shyamala S Kundar, Member, NCW, has met with Officials from the Women Child Department, Sakhi One Stop Centre, Police & Labour Departments of Chikamangalur District, where she suggested creating more awareness concerning One Stop Centre-Sakhi and woman helpline number 181. She also told to provide information about Labour laws in India for the women laborers working at estates. She opined that the Stree Shakthi Bhavana should provide training for selfemployment and organize other Stree shakti activities and programs and stressed the need to provide financial aid to self-help woman groups. Seventy-eight cases under the Domestic Violence Act were registered in Chikkamagalur, out of which 13 cases were referred to Court. And, about 27 cases came to be closed through counselling provided by CDPO, and 25 cases remain pending, to which Hon'ble Member advised to complete possible through as many cases as counselling itself.

NCW believes that a safe and healthy environment for women students and employees on Higher Educational Institutions (HEIs) campuses is a necessary precondition to quality education and research.

The HEIs can play a significant role in ensuring women's safety and providing a healthy environment by putting in place fool proof mechanisms and impregnable safety standards. The key lies in institutionalizing the best practices and standard operating procedures to deal with women-related issues on the campuses substantively. For this purpose, Dr. Rajul L. Desai, Member, NCW conducted meeting with Internal Committee Members of various Universities at Dehradun, Uttarakhand.

Extension of Quiz on "Gender Sensitization and Legal Awareness Program" with MyGov till 31st January 2021

The Commission launched an Open 'Gender Sensitization and Legal Awareness Quiz' through MyGov Portal on 14th November 2020. Initially, the duration of the Quiz was from 14th November to 31st December 2020. Now the Quiz duration has been further extended till 31st January 2021 as a good number of 42,099 participants have been recorded on 29th December 2020.

The program aims to teach equality, inclusivity, and diversity among adolescent boys and girls, essential for building a healthy society. Moreover, knowledge of laws relating to women and gender sensitization is crucial for balanced development of young minds; it will also help students build correct values, selfdiscipline, and national spirit.

Psychiatric Home and Custodial Homes Reform Cell

As part of its statutory mandate, the Commission has been conducting surveys/inspections of places where women are housed. However, due to the COVID-19 pandemic, physical inspections were interrupted, and the Commission continued to analyse the information received in prescribed proforma from Psychiatric Homes in the Government sector. The Commission has interpreted information and made recommendations for Lumbini Park Mental Hospital, Kolkata, West Bengal, and Psychiatric Diseases Hospital GMC, Jammu.

The Commission has received Action Taken Reports (ATR) from Psychiatric Homes on the recommendations made by the Commission. Action Taken Reports received from State Mental Health Institute, Dehradun, Uttarakhand, and RINPAS, Ranchi, Jharkhand were scrutinized. Accordingly, inputs/ suggestions were communicated to the concerned authorities for necessary action.


The information received in the prescribed proforma from 370 One Stop Centres were scrutinized to review their functioning and assess their ability to protect the rights and dignity of women residing therein. Reminders were sent to the remaining One Stop Centres to furnish information in the proforma.

Women Safety Cell

The National Commission for Women, in collaboration with the Tata Institute of Social Sciences (TISS) and Delhi Police, has been implementing Violence Free Home: A Woman's Right pilot project in Delhi and 7 States (namely Bihar, Assam, Meghalaya, Punjab, Madhya Pradesh, Odisha, and Tamil Nadu) to help women survivors of violence. The Memorandum of Understanding between the National Commission for Women, Tata Institute of Social Sciences, and Delhi Police has been extended to continue the pilot project until 31st March 2021.
