



Tender Notice

National Commission for Women (NCW) invites quotation for disposal of **USED 125KVA 3 Phase 415V, Silent DG Set**, Water Cooled, Engine Model KG125WS, coupled with Kirloskar Green Make Alternator with AMF Panel on "AS IS WHERE IS AND NO COMPLAINT BASIS". The DG Set is installed at ground floor at 4 Deen Dayal Upadhyaya Marg, New Delhi-110002. The DG Set was installed in 2011.

The parties interested to purchase the DG Set may send their quotation in the proforma at Annexure II alongwith earnest money of Rs.40,000/- (Rupees forty thousand only) in the form of Demand Draft drawn in favour of P&AO, National Commission for Women, payable at New Delhi in a sealed cover super scribed as "quotation for disposal of DG Set". The quotation may be sent by registered post or by speed post to the Deputy Secretary, National Commission for Women, Plot No.21, Jasola, New Delhi-110025 alongwith EMD and other requisite documents so as to reach on or before 3 P.M. on 03.03.2017. The quotations can also be handed over personally at the reception of the National Commission for Women, Plot No.21, Jasola, New Delhi-110025. The bids shall be opened on the same day at 4 P.M. The tenders who wish to be present at the time of opening may do so. The terms and conditions of the tender are given in Annexure I.


Annexure I

TERMS AND CONDITIONS FOR TENDER FOR DISPOSAL OF USED 125KVA 3 PHASE 415V, SILENT DG SET, WATER COOLED, ENGINE MODEL KG 125 WS COUPLED WITH KIRLOSKAR GREEN MAKE ALTERNATOR WITH AMF PANEL

1. The item to be disposed off is strictly on "AS IS WHERE IS AND NO COMPLAINT BASIS". All items together have to be bid for as a composite unit and no part disposal will be entertained.
2. The DG Set is installed at Ground Floor at 4 Deen Dayal Marg, New Delhi – 110002 and is in operational condition.
3. Sealed bid is to be submitted in the prescribed proforma in an envelope super scribed as "Bid for Disposal of DG Set" at a reserve price of Rs.4,00,000/- (Rupees four lakhs only). Bidders shall submit Earnest Money Deposit (EMD) of Rs.40,000/- (Rupees Forty Thousand Only) alongwith the bid. EMD shall be in the form of Demand Draft/Pay Order drawn on any Scheduled Commercial Bank in favour of PAO, National Commission for Women, payable at New Delhi. EMD submitted by the bidders shall not carry any interest.
4. The bidders shall submit self-attested copy of CST/VAT Registration certificate and self-attested copy of PAN Card alongwith the bid.
5. The Bids alongwith the prescribed EMD and requisite documents shall be submitted in a sealed envelop to the Under Secretary, National Commission for Women, Plot No.21, Jasola Insitutional Area, New Delhi-110025 latest by 3.00 P.M. on 03.03.2017.
6. The item to be disposed off can be inspected by the prospective bidders. For any information the bidders may contact the Admin Section.
7. The used DG Set shall be sold on "AS IS WHERE IS AND NO COMPLAINT BASIS". The bidder shall be deemed to have satisfied themselves about the nature, physical condition, dimension, size, weight, working condition, etc. of the USED DG Set by inspection. No guarantee or warranty as to the condition of the Used DG Set or its quality or its fitness for any specific purpose or use shall be allowed. It should be clearly understood that no claims/complaints about the quality/quantity/conditions/fitness for use shall be entertained by the NCW after submission of tender irrespective of whether the tenderer has actually inspected the equipment/material or not.
8. EMD of unsuccessful bidders would be refunded after issue of Award Letter to the successful bidder or within 30 days from the date of receipt of offer whichever is later. If the bidders withdraw or modify or amend their offer during the validity of tender, the EMD shall stand automatically forfeited.

9. EMD of successful bidder shall automatically be converted into Security Deposit for due fulfillment of the contract and refunded only after successful performance of the contract. No interest shall be paid on Security Deposit.
10. The Bid is to be submitted in Price Bid Format given in Annexure II.
11. The price quoted should be inclusive of all taxes, duties, levies, charges, etc.
12. Conditional offer shall be summarily rejected.
13. The bid should be kept open for 30 days.
14. Acceptance or rejection of the tender shall be entirely at the discretion of National Commission for Women.
15. The successful bidder shall be required to pay in advance the bid amount in full by way of Demand Draft/Pay Order drawn on a Scheduled Commercial Bank in favour of P&AO, National Commission for Women, payable at New Delhi within five working days from the date of issue of Award letter. No part payment shall be accepted.
16. The NCW reserves the right to accept or reject the highest bidder without assigning any reason and no claim/complaint in this regard shall be entertained by NCW
17. The NCW reserves the right to withdraw sale of material in full or part thereof or cancel the tender at any stage prior to the acceptance of the tender at their sole discretion without assigning any reason whatsoever.
18. In case the buyer fails to deposit the full material value within the stipulated time the contract shall be treated as cancelled. The Security Deposit shall be forfeited and the bidder will have no claim on such immaterial/item.
19. The successful bidder, after payment of bid amount shall be required to lift all the items and clear the site within a period of 5 days from the date of intimation by National Commission for Women.
20. The buyer shall lift the allotted quantity of Used DG Set by employing their own labour and transport at their own cost within the stipulated time prescribed as per tender/award letter. The buyer shall observe the rules and regulations and working hours suitable for the National Commission for Women. The buyer shall lift the used DG Set only after complying with the provisions of advance payments and against the Award Letter issued by NCW. The buyer shall note that no lifting shall be allowed on weekly holidays and closed holidays observed by the NCW or beyond office hours.
21. All necessary formalities as per the Factory Act, Rules & Regulations & Govt. Rules & Regulations shall be maintained by the buyer during lifting of Used DG Set.

22. The used DG Set under contract shall be removed on "AS IS WHERE IS AND NO COMPLAINT BASIS" at buyers own risk & cost. The buyer shall not be provided with any equipment, including dozer, loader or any item like gas, power, water facilities etc. by NCW. The buyer shall arrange for any of these equipments, if necessary, at their own cost and they shall take prior permission from NCW for such requirements.
23. The buyer shall not indulge in or carry out any operation which could interfere with NCWs' plant installation/operation, if any, in the area or in the vicinity of site.
24. If any damage or loss is caused to the employees, or the property of the NCW, or if any claim is made against the NCW by reasons of any acts of omissions or negligence on the part of the buyer or on the part of their Agents or representatives, or their employers, the NCW shall be entitled to recover such losses and damages or claim as may be ascertained by the NCW (the NCW's assessment of such loss or damages shall be final and binding on the buyer), from any amount due to the buyer as the Security Deposit &/or deposit against unlifted material &/or surplus deposit without prejudice to NCW rights to take further action under the contract as well as recover such losses, damages or from any other money due or becoming due under any other sale of contract with NCW or from the buyer directly.
25. The successful bidder shall be required to restore at his/her own cost any damages that may occur due to dismantling, removing of the items to the satisfaction of National Commission for Women, after which the Security Deposit will be refunded.
26. If used DG Set is not lifted within the lifting schedule, the contract shall be deemed to have been cancelled and NCW shall be at liberty to dispose them off without prejudice to its rights against the buyer. No money against the unlifted material shall be refunded and the Security Deposit is liable for forfeiture.
27. National Commission for Women reserves the right to accept or reject any or all the bids without assigning any reason.
28. All the bidders/purchasers shall be deemed to have read and acquainted themselves with the terms and conditions of the Bid/Sale and given their bids subject to these terms and conditions.
29. Only courts in Delhi shall have exclusive jurisdiction to adjudicate on any matter arising under/or relating to the Bid/Sale.
