Editor's Column

The Supreme Court's recent ruling that any compromise between a rape convict and a victim cannot be a ground to reduce the sentence of imprisonment is extremely pertinent. The rapist's offer to marry the rape survivor could never be a basis for letting him off lightly nor does it minimize the gravity of the offence, even if the survivor forgives the accused.

The Court said "rape is a noncompoundable offence and it is an offence against the society and not an individual and, therefore, it cannot be left for the parties to compromise and settle". Moreover, there is always an apprehension that the victim might have been pressurized by the perpetrator to marry him to reduce the sentence. At times, it could be the pressure by the parents to go for a compromise to overcome the social stigma of rape or coercion exerted by the Khap Panchayats to force a union. Sometimes, it could be also due to financial compensation provided by the rapist's family, in exchange for not



pressing charges.

The Supreme Court has rightly expressed serious concern about the tendency of many trial courts to impose lighter sentences on rape convicts once they offer to marry the survivor. The Court said that punishment should always be proportionate and commensurate with the gravity of an offence.

Moreover, unions forged in brutality rarely have happy endings.

A girl from Ranchi recently lodged a rape complaint against her living partner. She married the accused and within a month came back to her parent's place claiming that her husband and his friends gangraped her every night after drinking. Many-a-times, after marriage, the girls are either tortured by their husbands or thrown out of their houses.

Thus, Supreme Court's directives to subordinate courts against any casual or cavalier use of judicial discretion to reduce the quantum of punishment is timely and laudable. As ninety percent rape cases in the country end in acquittal, it has expanded the scope of plea for justice on behalf of a gangrape survivor and has also sought responses from all state governments on the question of rehabilitating such victims.

complaints related to domestic violence, divorce, maintenance and child custody. Some cases of rape and molestation were also being reported. • The Member addressed a conference organized by "Majlis" in Mumbai on "Negotiating Spaces, Fine tuning our demands of Rape Law". Speaking on the occasion, she said that rape not only caused physical injury but affects a woman's status and dignity and violative of her human rights.

From the Complaints Cell

The Commission received a complaint from Mr. X on behalf of his daughter alleging domestic violence by her husband and in-laws. Prior to this, the complainant alongwith his son went to Gandhi Nagar Police Station, Delhi and lodged a verbal complaint that he was not able to contact his daughter for the last 2-3 days. Thereafter, one police constable went with them and rescued the complainant's daughter from her matrimonial home where she was locked up by hers in-laws. Taking cognizance of the matter, hearings were conducted at the Commission. The complainant's daughter requested the Commission to get back her dowry articles and her 'streedhan' from the respondent as she did not wish to continue her marriage.

With the intervention of the Commission, two hearings were held, where it was decided by both the parties that they would file for divorce with mutual consent, wherein the respondent will pay Rs. 4,90,000 as full and final settlement to the victim. All dowry articles, such as clothes etc. along with gold jewellery were returned to the complainant at the Commission.

Important Decisions

- From now onwards marriage registration in South West Delhi will require couples to take an oath that they will never go for sex determination of their children. This will be attached to the marriage certificate, too. The district advisory committee came up with this initiative to prevent female foeticide and has also decided to make it mandatory for all pregnant women to submit address and ID proof at the time of hospital registration so that all births will be recorded accurately.
- To curb child marriages that are rampant in Rajasthan's rural areas, the state government has issued a directive that the date of birth of the bride and the groom should be printed on the invitation cards. If the printing press owners find either the bride or the groom is not of legal age, he should turn down the print order.
